

1.3 ISMS POLICY

It is the policy of VAIX to maintain an information management system designed to meet the requirements of ISO 27001:2013 in pursuit of its primary objectives, the purpose and the context of the organisation.

It is the policy of VAIX to:

- create a process and culture, which identifies the key company assets and puts in place processes and measures to ensure those assets appropriately secured, without requiring heavy centralized top-down controlling, but as part of the company culture
- make the details of our policy known to all other interested parties including external where appropriate and determine the need for communication and by what methods relevant to the business management system.
- comply with all legal requirements, codes of practice and all other requirements applicable to our activities; therefore, as a company, we are committed to satisfy applicable requirements related to information security and the continual improvement of the ISMS.
- provide all the resources of equipment, trained and competent staff and any other requirements to enable these objectives to be met;
- ensure that all employees are made aware of their individual obligations in respect of this information security policy;
- maintain a management system that will achieve these objectives and seek continual improvement in the effectiveness and performance of our management system based on "risk".

This information security policy provides a framework for setting, monitoring, reviewing and achieving our objectives, programmes and targets.

To ensure the company maintains its awareness for continuous improvement, the business management system is regularly reviewed by the management team to ensure it remains appropriate and suitable to our business. The Business Management System is subject to both internal and external annual audits.

Scope of the Policy

The scope of this policy relates to use of the database and computer systems operated by the company in pursuit of the company's business of providing Artificial Intelligence-based services to the online gaming and gambling sector and beyond. It also relates where appropriate to external risk sources including functions which are outsourced.
